

Life Gaming - Legends of Runeterra (Online Tournament)

Official Tournament Rules

VOID WHERE PROHIBITED BY LAW. NO FEE IS REQUIRED TO COMPETE IN THIS TOURNAMENT. THIS TOURNAMENT IS PRESENTED IN PARTNERSHIP WITH RIOT GAMES, INC. TO PARTICIPATE IN THE TOURNAMENT, YOU MUST HAVE AN EUW LEGENDS OF RUNETERRA ACCOUNT.

Life Gaming (the "Tournament") is a tournament that is open to the general public and sponsored by Gigabyte Aorus, Inc. ("AORUS" or "Sponsor") and in partnership with Riot Games, Inc. The Tournament is subject to all applicable federal, provincial, and local laws. Void where prohibited by law. The tournament is solely based on the digital card game Legends of Runeterra ("LoR").

1. ELIGIBILITY

The Tournament (as further described below) is open to individuals who are: (i) legal residents of Spain; and (ii) who are at least eighteen (18) years of age as of the date of registration. The Tournament consists of six (6) single-elimination rounds with a maximum of 64 participants in between two day.

To register for the Tournament, participants must complete the following steps:

- Log into your League of Legends account (if you do not have a League of Legends account, create one for free at

o LoR account must be in good standing, as determined by Riot Games and Sponsor in their sole discretion, to participate in the Tournament;

- Complete the registration form for the applicable tournament by providing all required information and following all on-screen instructions.

The Tournament will be held beginning June 27, 2020 and ending on June 28, 2020.

Registration Period beginning at 12:00 (GMT+2) on June 22, 2020.

Registration for the Tournament is limited to the first 64 registered participants. Any registered participants attempting to sign up for the Tournament after maximum capacity reached will not be eligible to participate unless informed otherwise.

Registered participants must check in to the applicable Tournament to complete the registration. The check-in period starts sixty (60) minutes prior to the Tournament start

time. Registered Participants have ten (10) minutes to join their respective “match room” once it is open at 11:50am (GMT+2) on both days.

By participating in the Tournament, you agree to Riot Games’ Terms of Use (<http://euw.leagueoflegends.com/en/legal/termsofuse>) and Privacy Policy (<https://www.riotgames.com/en/privacy-notice>); and Summoner’s Code.

2. Tournament Play

The Tournament will consist of competition in Legends of Runeterra (“LoR”).

Each round of the Tournament will proceed as described below:

- Region/Server: Europe West (EUW)
- Round Format: 1v1
- 64 Player Capacity
- Bracket Breakdown:

Day 1

Round 1 (Top 64) - Best of 1

Round 2 (Top 32) - Best of 1

Round 3 (Top 16) - Best of 1

Day 2

Round 4 (Quarter Finals) - Best of 1

Round 5 (Semi Finals) - Best of 1

Round 6 (Finals) - Best of 3

- Players compete in a one-on-one setting
- Best-of-1 matches
- Bracket is single-elimination, random seeding
- No Deck type limitation
- No pause time permitted
- No-show time is ten (10) minutes
- Match Win Conditions:
 - First player to get the opposing player Nexus to zero (0) or below wins the round
 - Once the player enters the discord channel, there will be clear instructions of tournament procedure (i.e. Round 1, TOP64 Grupo A - partida a1...etc)

Tournament Prize

- Players that reached TOP 16 of the tournament will receive one unit of Gigabyte Aorus Gaming exclusive merchandise (No shipping fee or any form of payment required for the delivery of this prize, however, an email will be sent from official LIFE Informatica email requesting for delivery address)
- Players that reached TOP 8 of the tournament will receive in game rewards for Legends of Runeterra (will automatically appear in the winners' account within 3-5 business days without any in game notification)

Additional terms

- As the win conditions do not account for a match ending in the destruction of a Nexus, players MUST report their own scores on the match page and provide screenshots in the event of a result dispute.
- Screenshots must be taken by both players after the game (both your own and your opponent's) and uploaded to their discord game room (i.e. partida a1)
- Players will have only ten (10) minutes to join the discord channel game room 10 minutes before the round starts. If your opponent does not show up or does not start the match in the allotted ten (10) minutes, please contact tournament administrator(s)
- If a player suffers a disconnection, the player will be given ten (10) minutes to reconnect to the game.
- Any real-time coaching of any player is strictly prohibited. Players are prohibited from using any third-party text, voice, or video chat services of any kind during a match.
- Players are allowed to stream their gameplay, provided such streaming has at least a three (3) minute delay. All streaming is at the player's own risk.
- All the players must respect The Summoner's Code and the League of Legends and Legends of Runeterra Terms of Use, any behavior against this rule will be penalized.
- If any manipulations of in-game software occur, such players will be banned permanently from any future Life Gaming events, and any/all information will be forwarded to Riot Games. If a player is caught abusing glitches, bugs, etc., to gain an advantage, they will be auto-disqualified.
- All decisions of Tournament administrators and Sponsor are final.

3. PRIZES

The Tournament prizes will be awarded as follows:

- 1st Place-8th Place

Legends of Runeterra in game rewards (both coins and shards)

- 1st Place-16th Place

Official exclusive Aorus Gaming merchandise (one unit)

- Top submitted best video gameplays

1-8 units of Official Riot Games merchandise (relative to total number of best video gameplays submitted)

Prize Terms

All winning players will be notified through email requesting for an official name and address in order to deliver their respective prizes, limited to locations within Spain. Winning players will be contacted directly by Riot Games and the prizing will be distributed directly to such winners' LoR accounts. All prizes are awarded "AS IS." Neither Life Informatica S.L., Gigabyte Aorus nor Riot Games, Inc. affiliates make or offer any warranty or guarantee, either express or implied (including, without limitation, quality, merchantability and fitness for a particular purpose) in connection with this Tournament or any prize. Prize details and availability is subject to change, in which case a prize of equal value may be substituted at Life Gaming's sole discretion.

Prizes consist only of the items listed, are non-transferable, with no cash redemption or substitution except at Life Gaming's sole discretion. Prizes are subject to terms, conditions, expiration dates, and restrictions imposed by the manufacturer/issuer of the prize. Federal, state, and local taxes on prizes, if any, and any other costs, fees and expenses not listed above as specifically included as part of the prize are the sole responsibility of each Player. ALL TAXES ARE THE SOLE RESPONSIBILITY OF THE WINNER.

An IRS form 1099 and other tax-related forms and documents may be issued by Life Informatica S.L. if required by law. If you are a minor in your jurisdiction of residence, then a legal guardian must complete any required documentation on your behalf.

4. REPRESENTATIONS AND WARRANTIES

Each Player (for the remainder of these Tournament Rules, collectively “you”) represent and warrant:

A. You will not engage in any unsportsmanlike conduct during the Tournament. If Life Informatica S.L. or any designated administrator needs to resolve any issue relating to your conduct, then any decision made will be final and not appealable except in Life Informatica S.L. ’s or Tournament administrator’s sole discretion. Any offensive remark may, as determined in Life Gaming’s sole discretion, result in disqualification.

B. You will not violate or infringe upon the rights of any person or entity, including without limitation copyrights, trademarks or rights of privacy or publicity, and must not act in any way that, in Life Informatica S.L. sole discretion, is defamatory, threatening, indecent, obscene or offensive, pornographic, lewd, sexually explicit, inappropriate, objectionable, unlawful, is in violation of, or is contrary to any applicable laws or regulations. You must not disparage or cast a negative light on any person, entity, or brand, product, or service.

C. You will not reference any names, products or services of any company or entity or any third-party trademarks, logos, trade dress or promotion of any brand, product, or service during your participation in the Tournament.

D. You will comply fully with these Official Tournament Rules and the Game Play Rules.

E. You will comply with all of Riot Games, Inc.’s, Life Informatica S.L. ’s, and Discord’s terms and requirements, as applicable.

F. You will abide by all laws, regulations, ordinances, and rules, and that you will not harm, attempt to harm, or threaten to harm any person (including yourself) or property in relation to or during your participation in the Tournament. If you violate any of the forgoing Representations and Warranties, you may be disqualified from the Tournament at any time in Sponsor’s sole discretion. You agree to reimburse Life Informatica S.L. and Related Entities in full for any losses, damages, and expenses, including reasonable legal fees that you may sustain from you breaching these Tournament Rules.

5. LICENSES/RELEASES/RIGHT OF PUBLICITY

By participating in the Tournament: (1) you grant to Life Informatica S.L. a perpetual, irrevocable, non- exclusive, worldwide, royalty-free, sublicensable, freely assignable license to reproduce your registration and any images, descriptions, audio, or video of your participation in the Tournament and to otherwise use, exploit, copy, modify, adapt, edit, publish and display your registration and any images, descriptions, audio,

or video of your participation in the Tournament in any form, manner, venue, media or technology now known or later developed for any and all purposes, including, without limitation, for purposes of trade, advertising, and promotion as Life Informatica S.L. or and its licensees or assignees determine, without further compensation, notification, or permission; (2) you hereby waive any moral rights you may have in any images, descriptions, audio, or video of your participation in the Tournament in favor of Life Informatica S.L. ; and (3) you also grant to Life Informatica S.L. the worldwide, perpetual, irrevocable, fully sub-licensable, and freely transferable right, but not the obligation, to use any and all names, identities, titles, likenesses, distinctive appearances, physical likenesses, images, portraits, pictures, photographs (whether still or moving), screen personas, voices, vocal styles, statements, gestures, mannerisms, personalities, performance characteristics, biographical data, signatures, and any other indicia or imitations of identity or likeness listed, provided, referenced, or otherwise contained in your registration or your Tournament participation for purposes of advertising and trade, in any format, medium, or technology now known or later developed without further notice, approval, or compensation, unless prohibited by law. At Life Informatica S.L. 's request and in its sole discretion and to further document the foregoing, you agree to execute an assignment and release transferring all rights and ownership, if any, any images, descriptions, audio, or video of your participation in the Tournament to Life Informatica S.L. , the form of such assignment to be determined by Life Informatica S.L. in its sole discretion.

6. WINNER NOTIFICATION/RELEASES:

Confirmation that a Player is a potential prize winner will be sent via email or via phone number on or about the same business day of the completion of the respective event(s) in this Tournament. Each Player may be required, in Life Informatica S.L. 's sole discretion, to complete and return an Affidavit of Eligibility (or Declaration of Eligibility), a scan or photo of government-issued ID, Release of Liability and/or, if legally permissible, a Publicity Release before claiming a prize. If you are a minor in your jurisdiction of residence, then your legal guardian must complete any required documentation on your behalf.

7. PUBLICITY & MARKETING:

Your participation in the Tournament constitutes permission, but not the obligation, to Life Informatica S.L. to use your name, identity, title, likeness, distinctive appearance, physical likeness, image, portrait, picture, photograph (whether still or moving), screen persona, voice, vocal style, statements, gesture, mannerism, personality, performance characteristic, biographical data, signature, and any other indicia or imitation of identity or likeness for purposes of advertising and trade, in any medium, without further notice, approval, or compensation, unless prohibited by law. 's e-mails). The information you provide will only be used in accordance with Life Informatica S.L. 's Privacy Policy.

8. NO LIABILITY & INDEMNIFICATION:

By entering this Tournament, you agree to release, discharge and hold harmless Life Informatica S.L. , Riot Games, Inc., Gigabyte Aorus, Discord, Inc., and their respective directors, officers, employees, agents and assigns (the "Released Parties") from any claims, losses, and damages arising out of, or relating to, your participation in this Tournament or any Tournament-related activities and the acceptance and use, misuse, or possession of any prize awarded hereunder (including, without limitation, any misrepresentation made by the entrant in connection with the Tournament; any non-compliance by the entrant with these Official Rules; claims brought by persons or entities other than the parties to these Official Rules arising from or related to the entrant's involvement with the Tournament; acceptance, possession, misuse or use of any prize or participation in any Tournament-related activity or participation in this Tournament; any malfunction, error or other problem arising in connection with the collection, processing, or retention of registration information; any software, hardware, internet connection, or malfunction, error, or other problem affecting an entrant's participation in the Tournament, or any typographical or other error in the printing, offering or announcement of any prize or winner). The foregoing includes, without limitation, any claim for personal injury, property loss or damage, or death arising in any way in connection with the Tournament.

9. OTHER TERMS:

Decisions of Life Informatica S.L. on all matters related to the Tournament are final and binding. Life Informatica S.L. reserves the right to cancel or modify the Tournament for any reason, including but not limited to, if fraud, misconduct or technical failures destroy the integrity of the Tournament, or if a computer virus, bug, or other technical problem corrupts the administration, security, or proper administration of the Tournament as determined by Life Informatica S.L. , in its sole discretion. CAUTION:

ANY ATTEMPT TO DELIBERATELY DAMAGE OR UNDERMINE THE OPERATION OF THIS TOURNAMENT MAY BE A VIOLATION OF CRIMINAL & CIVIL LAWS. Life Informatica S.L. RESERVES THE RIGHT TO DISQUALIFY AND/OR SEEK DAMAGES FROM ANY INDIVIDUAL MAKING ANY SUCH ATTEMPTS TO THE FULL EXTENT PERMITTED BY APPLICABLE LAW.

10. RIGHT TO DISQUALIFY:

Life Informatica S.L. reserves the right to disqualify or prohibit the participation of an individual if fraud or tampering is suspected; if the individual fails to comply with any requirement of participation or with any provision in these Official Rules; if the individual's behavior or communication at any point is disruptive, may or does cause damage or to any person, property, or reputation of Life Informatica S.L. ; or is otherwise not in accordance with all applicable laws and generally accepted social practices as determined in Life Informatica S.L. 's sole discretion.

11. GOVERNING LAW/JURISDICTION:

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of participants or Life Informatica S.L. in connection with the Tournament shall be governed by and construed in accordance with the laws of Spain, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws, and all entrants shall be deemed to have agreed to submit to the exclusive jurisdiction of the provincial or federal courts (as applicable), situated in Barcelona, Catalunya. Claims may not be resolved through any form of class action.

12. SEVERABILITY:

If any provision(s) of these Official Rules are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

13. DISCREPANCY:

In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any Tournament-related materials, including but not limited to the Tournament entry form, point of sale, television, print or online advertising, the terms and conditions of these Official Rules shall prevail, govern and control.
